CONGRESS SIGNALS CONTINUED COMMITMENT TO THE COLUMBIA BASIN PROJECT

FY 2026 ENERGY AND WATER BILL PASSES CONGRESS, AWAITS PRESIDENTIAL SIGNATURE

Congress has successfully passed the FY 2026 three-bill appropriations minibus containing the Energy and Water Development title, sending the legislation to President Trump for his signature. The House approved the package on January 8, 2026, followed by Senate passage on January 15, 2026, in an 82-15 vote. As of January 18, the President has not yet signed the legislation into law. Policy analysts and appropriations trackers anticipate the bill will be signed before the current continuing resolution expires on January 30, 2026, though the White House has not announced a specific signing date.

The House Committee on Appropriations included important report language in H.Rept. 119-213 directing the Bureau of Reclamation to provide a comprehensive briefing on the Columbia Basin Project. Reclamation is directed to provide to the Committee not later than 180 days after enactment a briefing on the costs and benefits of continued progress, considering impacts to local Tribal populations, salmon habitat, agricultural production and employment, and food security. The 180-day deadline means the briefing must be completed by approximately mid-to-late July 2026, creating a concrete timeline for federal agency engagement and ensuring the issue remains on the congressional agenda during the second half of 2026.


This congressional directive establishes clear congressional recognition of the Columbia Basin Project's critical role in regional agriculture and water security, acknowledging the dire groundwater depletion in the Odessa Subarea, where wells now reach depths of 2,400 feet and produce water with dangerously high sodium concentrations. By directing the Bureau of Reclamation to conduct a comprehensive cost-benefit analysis, Congress is signaling sustained federal interest in project completion and positioning it as a priority for future investment.

WHAT'S NEXT: TRANSPORTATION-HUD BILL AND TYPE 3 BRIDGE PROGRAM FUNDING

The Senate's FY 2026 THUD bill (S. 2465) includes \$25 million for a competitive Type 3 highway bridge program specifically designed to address county-owned bridges crossing Bureau of Reclamation water conveyance structures. This Type 3 bridge program builds upon strategic federal and state appropriations the Washington congressional delegation has already secured for East Low Canal bridge infrastructure. Senator Patty Murray secured approximately \$3.88 million in federal appropriations for Adams County to replace the Sackman Road bridge, with Washington State Senator Mark Schoesler championing approximately \$924,500 in state transportation budget funding to provide the required local match. In FY 2024, former Representative Cathy McMorris Rodgers secured \$3.978 million for Adams County to replace the Booker Road bridge, while Senator Murray secured \$3.888 million for Grant County to replace the Road W Southeast bridge (Bridge 247) near Warden. Senators Murray and Cantwell together secured \$1.7 million for Adams County for preliminary engineering and design work for five remaining bridges across the county.

The East Low Canal widening project requires these bridge replacements and extensions, as existing structures are inadequate for the expanded canal configuration. The new \$25 million Type 3 bridge program is specifically structured to help fund construction of the remaining bridges, making Adams and Grant counties significantly more competitive for these federal dollars. Adams and Grant counties will be well-positioned to compete

for these funds, having already demonstrated project readiness through completion of initial bridge replacements and ongoing design and engineering work.

The passage of the FY 2026 Energy and Water Development appropriations bill and the Senate's Type 3 bridge program in the THUD bill represent meaningful progress in the Columbia Basin Development League's advocacy for completion of the Columbia Basin Project. The League's sustained commitment to advancing these priorities – through legislative testimony, stakeholder coordination, and persistent engagement with federal and state agencies – has been instrumental in securing these critical appropriations and policy directives. These federal investments are direct results of the League's members making their voices heard in Congress and state legislatures, elevating the urgency of Columbia Basin Project expansion to the attention of policymakers. The League will continue advocating for project completion and supporting the Bureau of Reclamation's briefing process and bridge program implementation.

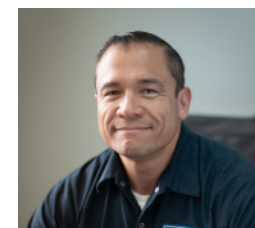

CELEBRATING A WATER CHAMPION

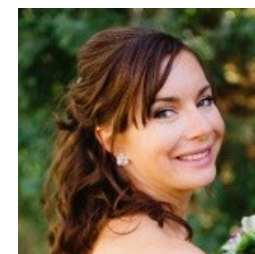

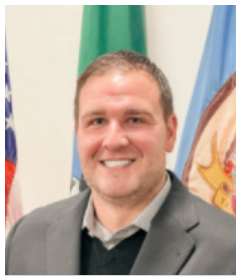

BUILDING BIG THINGS:

Reflections from the 2025 CBDL Conference & Annual Meeting

The Columbia Basin Development League's 2025 Conference & Annual Meeting brought together growers, policymakers, agency leaders, community partners, and advocates for a full day of connection, conversation, and collaboration—grounded in a shared commitment to the future of the Columbia Basin Project.



The day began with coffee and connections, setting the tone for relationship-building and idea-sharing before attendees moved into a robust and thoughtfully curated program. Opening remarks, emceed by Erik the Peanut Guy of the Tri-City Dust Devils, alongside CBDL Chairman Jon Erickson, framed the day around honoring the visionaries who built the Basin – and those carrying that work forward.

A FULL DAY OF INSIGHT, LEADERSHIP, AND VISION

Throughout the day, speakers and presenters shared insights on agriculture, water management, energy, conservation, tribal issues, and infrastructure investment – reflecting strong state and federal involvement.

Highlights Included:

- State of Agriculture in Washington, with Derek Sandison, Director of the Washington State Department of Agriculture, examining the forces shaping the agricultural economy.
- A legislative update featuring Representative Tom Dent, Representative Mary Dye, and Senator Judy Warnick, who discussed recent legislative successes and priorities ahead for the Basin.
- Video remarks from U.S. Senator Patty Murray, Congressman Michael Baumgartner, Congressman G.T. Thompson, and Congressman Dan Newhouse, underscoring the national importance of the Columbia Basin Project, along with a letter shared from U.S. Senator Maria Cantwell.
- Shawn Logan, Mayor of Othello, who was joined by Robin Adolphsen, Public Works Director and City Engineer for the City of Othello, highlighting the role of local leadership and infrastructure in supporting Basin communities.
- Federal and regional insights from the Bureau of Reclamation, including an interactive panel with irrigation district leaders offering a practical “view from the canal”.
- Updates on power, sustainability, and innovation from Northwest RiverPartners, the Office of Columbia River, and the Columbia Basin Sustainable Water Coalition.
- Reflections on conservation and future-focused water solutions from NRCS leadership, the Columbia Basin Conservation District, and OGWRP landowners.

Established in 2012, the Perseverance Award recognizes individuals or organizations who demonstrate the ability to carry on in the face of complexity, challenge, and long-term effort – hallmarks of work associated with the Columbia Basin Project. League membership is not required for this honor.

MOMENTUM ON THE GROUND:

A Pivotal Year for the Odessa Groundwater Replacement Program

The year 2025 will long be remembered by the Odessa Groundwater Replacement Program (OGWRP). After two decades of planning, coordination, and persistence, the Program reached major milestones that are continuing to deliver measurable results on the ground. These accomplishments reflect the strength of partnerships at every level – from on-farm to Washington, D.C. — and position OGWRP for continued success in 2026.

MAJOR MILESTONES ACHIEVED IN 2025

One of the most significant achievements in 2025 was the completion of the EL 86.4 public irrigation system, the second OGWRP system to be constructed by East Columbia Basin Irrigation District. This system also represents the first of the Natural Resources Conservation Service (NRCS) investments on the ground, including 12 producer contracts totaling over \$5.3 million in on-farm investments.



KEY OUTCOMES OF THE EL 86.4 SYSTEM INCLUDE:

- Conversion of 5,426 acres from deep well irrigation to Columbia River surface water delivered through the Columbia Basin Project.
- Removal of 16 deep wells from operation.
- Conservation of approximately 16,143 acre-feet – or 5.3 billion gallons – of groundwater annually from the Odessa Subarea Aquifer.

Building on this success, ECBID began construction on two additional public systems, the EL 84.7 and 80.6, utilizing a combination of state and NRCS funding.

SIGNIFICANT FUNDING PROGRESS

In addition to construction milestones, 2025 brought important funding advancements that will support the next phase of OGWRP implementation.

NOTABLY:

- Through strong legislative support and leadership, an additional \$38.5 million was secured to advance the EL 22.1 system.
- NRCS budgeted \$10 million to support OGWRP farmers with on-farm buildouts, allocating approximately \$2 million annually over the next five years.

These investments are essential to ensuring that public infrastructure is paired with on-farm improvements, allowing producers to fully transition from groundwater to surface water delivery. Together, public system construction and on-farm buildouts form the foundation of a successful and durable groundwater replacement strategy.

LOOKING AHEAD TO 2026

As OGWRP enters 2026, momentum remains strong. Several key efforts are already underway or anticipated in the coming year, including:

- Continued construction on the EL 84.7 and EL 80.6 public systems.
- Ranking and selection of on-farm buildout applications by the Columbia Basin Conservation District (CBCD) and NRCS using available funding.
- Preparation for the next round of NRCS Regional Conservation Partnership Program (RCPP) funding.
- Completion of the Odessa Watershed Planning Project (PL-566) Watershed Plan – effectively opening a new funding source for the remaining OGWRP public systems.

CBCD anticipates that NRCS will announce the next RCPP round this January. In response, CBCD plans to submit applications to support the EL 22.1 system and potentially the EL 11.8 system. These applications will build on recent successes and seek to leverage the State's significant investments to keep OGWRP moving forward as quickly as possible.

BUILDING ON A STRONG FOUNDATION

The progress achieved in 2025 reflects years of collaboration, shared vision, and sustained commitment from producers, local districts, agencies, and elected leaders. Most importantly, it demonstrates that OGWRP is delivering on its promise – producing real groundwater conservation, improving water supply reliability, and supporting the long-term viability of agriculture in the Columbia Basin.

As construction continues and new investments come online, OGWRP is well-positioned to build on this momentum in 2026, turning decades of planning into lasting benefits for the basin and beyond.
