## Operations Hold Steady While Appropriations Negotiations Continue

#### **OGWRP ENDURES FEDERAL SHUTDOWN**

The ongoing federal government shutdown, which began October 1, 2025, has caused only limited disruption to the core functions of the Columbia Basin Project (CBP). Despite the lapse in appropriations and broader federal uncertainty, all critical dam operations, water delivery, hydroelectric generation, and flood control infrastructure continue uninterrupted. Government agencies, including the Bureau of Reclamation and the U.S. Army Corps of Engineers, have maintained mission-essential activities, ensuring stable water supply and power reliability for communities and producers throughout the Basin.

Administrative and future-oriented work supporting the CBP is temporarily paused. These include grant processing, WaterSMART program administration, contract approvals, infrastructure modernization planning, and Title XVI water recycling initiatives. While this may delay new project development and upgrades, it poses no immediate threat to the safety or daily functioning of existing water and energy infrastructure.

The greatest operational constraint affects the USDA's Natural Resources Conservation Service (NRCS), which provides conservation technical assistance and program payments. During the shutdown, nearly 42,256 USDA employees have been furloughed nationally – almost 50% of the agency's workforce – with the NRCS particularly impacted as 95% of its 11,000 employees (over 10,000 staff) are furloughed. As a result, Columbia Basin producers temporarily lose access to NRCS technical planners and cannot receive cost-share reimbursements for conservation practices through federal programs. These delays are inconvenient, but should remain manageable unless the shutdown extends significantly, with agencies preparing to address processing backlogs once appropriations resume.

Overall, the Columbia Basin Project remains resilient in the face of the shutdown. Essential water delivery, power generation, and dam operations continue without interruption, while the primary disruptions are confined to deferred administrative activities, technical assistance, and long-term project planning – not to immediate water or infrastructure needs.

#### SECOND MINIBUS COULD ADVANCE ENERGY AND WATER PROJECTS—NEGOTIATIONS CONTINUE ON FIRST PACKAGE

Representative Tom Cole, Chair of the House Appropriations Committee, has voiced strong support for advancing a second "minibus" appropriations package, which would include the Energy and Water Appropriations Bill crucial for the CBP. Cole emphasized that passage of the Bill is necessary to sustain investment in large-scale water infrastructure, hydroelectric generation, and continued funding for the Bureau of Reclamation and Army Corps of Engineers – all central agencies supporting CBP dam operations, flood control, and water delivery. Specifically, the Energy and Water Bill covers federal outlays for facility maintenance, modernization grants, hydropower reliability, and WaterSMART program allocations, shaping the fiscal outlook for water efficiency projects throughout the Basin.

Negotiations on the first three-bill minibus package remain stalled, with House and Senate leaders working through differences in defense, veterans, and legislative branch appropriations. Despite efforts to reconcile funding levels and program priorities, several votes have failed to clear the path for final passage, prolonging the broader impasse that has partly contributed to the current government shutdown. The first minibus is still in conference, with both chambers actively seeking compromises. Cole and other appropriations leaders remain hopeful that resolution on the initial minibus will allow subsequent packages, including energy and water, to move forward and bring relief to priority programs such as those underpinning the CBP.

The Washington State Legislature passed a bill in March 2025, requesting that the Washington State Transportation Commission designate the I-90 bridge over the Columbia River near Vantage as the "Medal of Honor Bridge". 
